## Current Position at CWA

Anthony Severn joined CWA as a technical officer/surveyor in 1983 and has been a Director of the Company since 1992. Examples of these include cargo handling, pumping, venting, COW, ballasting, tank cleaning, bunker supply and consumption, integrity of containment systems and compliance with international regulations (IMO, SOLAS, MARPOL, US Coast Guard, etc). Anthony has performed detailed analysis of all aspects of oil loss control and contamination matters on ships, in refineries and tank farms, and is responsible for the continued development of CWA software concerned with loss reconciliation (CAROL), LPG cargo calculation, trim/stability, etc. He was a founder member of the Institute of Petroleum (Energy Institute) Oil Loss Control and Oil/LPG Measurement Committee in 1985 which produced detailed manuals outlining procedures for cargo surveyors in the measurement of oil cargoes (crude oil, petroleum products and LPG). Anthony represented the Society of International Gas Tanker and Terminal Operators (SIGTTO) as a member of a BSI Committee dealing with Measurement of Light Hydrocarbons. Anthony was also on a SIGTTO working panel producing Guidelines in the Shipboard Odourisation of LPG cargoes.
